Discussion: They are planning to be an ACAOM accredited school. In 4-6 weeks they should have permit permission to open. According to Yeaji Suh all clinical staff will need to be licensed in the state but not for the first couple of years. ACAOM standards calls for substantial faculty with extensive knowledge, experience and background. Minimum passing GPA to be established at 2.5 (between a C and B). Their first term open will include 3 faculty members. They will not have any herb or acupuncture faculty until Second term.
