1. Qualifications : An attorney who is licensed in the State of Nevada and understands fully the system of Doctor of Oriental Medicine in the State of Nevada in order to advise and represent the Board and protect the public.
 2. Salary : Not more than \$350.00/hr
 3. Job duties are to advise and represent regarding:
 - i. The issues regarding unlicensed practice of Oriental Medicine, including Physical Therapist's Dry Needling;
 - ii. The issues regarding the revised proposed new regulation;
 - iii. The issues regarding the establishment and maintenance of the school of Oriental Medicine in the State of Nevada;
 - iv. The issues regarding any legal actions or litigation against the Board; and
 - v. The other issues requested by the Board.
 4. The above jobs for Independent Legal Counsel should be given at the discretion of the President of the Board when the Board needs the work of Independent Legal Counsel.

1. Job description for Independent Legal Counsel: The Board's Executive Director initiates the job description with DAG's help, referring to Board's decisions concerning above qualifications, salary and job duties and the job description can be used as a basis for the contract when the President of the Board agrees with the job description.
 2. Advertisement for Independent Legal Counsel: The Board will advertise for Independent Legal Counsel on the Board's State Website for a month. The contents of the Board's decision regarding the qualifications, salary and job duties must be included in the advertisement.
