**4. Approve or disapprove of the minutes for the 2/12/2019 board meeting (For Possible Action).**

**5. Update from Susan Fisher regarding the legislative session (For discussion only).**

Ms. Fisher stated that SB 234, SB 171 and BDR 859 relate to data collection for medical professionals to be combined into one bill. Upon renewal, a set of questions which include home address, race, gender, sexual orientation are to be sent to UNLV medical school, the Office Of Statewide Initiatives (“OSI”), and the Department of Insurance to examine network adequacy. There is a lot of concern about these questions and whether they are mandatory or discretionary from the Board of Medical Examiner and Board of Osteopathic Medicine. Dr. Grant is concerned that people can be threatened because of their sexual orientation and that renewals could be held up because certain boxes are not checked. Mr. Smith echoed Dr. Grant’s concerns. Ms. Braster stated that these questions have nothing to do with a skill set. Dr. Tracey stated that concerns can be addressed through a letter or a call to a representative and people do not have to personally testify in a legislative setting. Ms. Fisher is on the working group and will keep the Board updated.

**6. Discussion regarding BDR 80-0646 (For Discussion Only).**

ED stated that this BDR is about Boards accepting credit cards for the payment of fees. Ms. Fisher stated that Boards will have the option to decide whether or not to accept credit cards and will be able to pass credit card fees along to its licensees. Smaller boards can accept credit cards through a state central purchasing agency. Dr. Grant asked whether set up fees will be borne by the state.

**7. Discussion regarding BDR 80-0527 (For Discussion Only).**

**8. Approve or disapprove of Wongu University’s request to pay \$1000 for the curriculum submission fee for 2018 (For Possible Action).**

ED stated that this matter was tabled from last year as the DAG had advised that the Board should wait for the new regulations regarding fees. The new regulations have now passed and Wongu’s curriculum approval fees have been lowered to \$1000 from \$5000. ED stated that Wongu has submitted \$1000 per year for 2018 and 2019. Dr. Grant stated that the Board does not have the expertise to do a curriculum review and will be deferring to ACAOM and the post-secondary education department. The Board will continue to oversee Wongu’s compliance with ACAOM and the post-secondary education standards so the \$1000 fee is reasonable.

SENATE BILL NO. 355—SENATOR PARKS

MARCH 18, 2019

Referred to Committee on Commerce and Labor

SUMMARY—Revises provisions relating to certain regulatory bodies which administer occupational licensing. (BDR 54-856)

FISCAL NOTE: Effect on Local Government: No.

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to regulatory bodies; clarifying that the scope of practice of chiropractors and physical therapists does not include dry needling; revising provisions governing the duties and powers of the State Board of Oriental Medicine; revising provisions governing the licensing of doctors of Oriental medicine; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law sets forth provisions governing the licensure and regulation of  
2 chiropractors, physical therapists and doctors of Oriental medicine. (Chapters 634,  
3 634A and 640 of NRS) Existing law defines the scope of practice of physical  
4 therapy and restricts persons licensed to practice physical therapy from practicing  
5 other forms of healing. (NRS 640.024, 640.190) Additionally, with certain  
6 exceptions, existing law prohibits a licensed chiropractor from piercing or severing  
7 any body tissue. (NRS 634.225) **Sections 12 and 13** of this bill clarify that the  
8 scope of practice of physical therapy does not include dry needling. **Section 1** of  
9 this bill clarifies that a chiropractor is prohibited from performing dry needling.  
10 **Section 3** of this bill provides that the practice of Oriental medicine specifically  
11 includes dry needling as well as moxibustion and cupping.

12 **Section 2** of this bill authorizes the State Board of Oriental Medicine to issue  
13 an endorsement to practice acupuncture point injection therapy to a doctor of  
14 Oriental medicine who meets certain requirements. **Section 5** of this bill eliminates  
15 the authority of the Board in existing law to fix and pay a salary to the Secretary-  
16 Treasurer. (NRS 634A.060) **Section 6** of this bill eliminates the requirement in  
17 existing law that the Board establish and maintain a list of accredited schools and  
18 colleges of Oriental medicine. (NRS 634A.080)

19 Existing law authorizes the establishment and maintenance of a school or  
20 college of Oriental medicine in this State if its establishment and curriculum is



21 approved by the Board. (NRS 634A.090) **Section 7** of this bill: (1) eliminates the  
22 requirement that the Board annually approve the curriculum; and (2) requires that  
23 the school or college be accredited by or have received at least candidacy status for  
24 accreditation from the Accreditation Commission for Acupuncture and Oriental  
25 Medicine or its successor organization and hold a current license issued by the  
26 Commission on Postsecondary Education. **Section 4** of this bill makes a  
27 conforming change.

28 Existing law requires an applicant for a license to practice as a doctor of  
29 Oriental medicine to: (1) pass a national examination in Oriental medicine  
30 administered by a national organization approved by the Board and a practical  
31 examination approved by the Board that tests certain subject areas; and (2) meet  
32 certain educational and other requirements. (NRS 634A.120, 634A.140) **Section 8**  
33 of this bill requires such an applicant to pass each examination required and  
34 administered by the National Certification Commission for Acupuncture and  
35 Oriental Medicine or its successor organization for certification in Oriental  
36 medicine. Additionally, **section 8** eliminates several subjects on the examination  
37 approved by the Board. For issuance of a license, **section 9** of this bill: (1) revises  
38 the educational requirements; (2) requires applicants to hold a current certification  
39 in Oriental medicine issued by the National Certification Commission for  
40 Acupuncture and Oriental Medicine or its successor organization; and (3)  
41 authorizes the counting of certain work experience in lieu of educational experience  
42 for applicants who attended a school or college of Oriental medicine before  
43 January 1, 2008.

44 **Sections 10 and 11** of this bill consolidate the requirements relating to the  
45 renewal of a license. **Section 14** of this bill eliminates the requirement in existing  
46 law that the applicant for the issuance or renewal of a license to practice Oriental  
47 medicine attest to knowledge of and compliance with certain guidelines of the  
48 Centers for Disease Control and Prevention concerning the prevention of  
49 transmission of infectious agents through safe and appropriate injection practices.  
50 (NRS 634A.144)

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 634.225 is hereby amended to read as follows:  
2 634.225 **1.** A chiropractor shall not pierce or sever any body  
3 tissue, *including, without limitation by performing dry needling,*  
4 except to draw blood for diagnostic purposes.

5 **2.** *As used in this section, "dry needling" has the meaning*  
6 *ascribed to it in NRS 634A.020.*

7 **Sec. 2.** Chapter 634A of NRS is hereby amended by adding  
8 thereto a new section to read as follows:

9 **1.** *A doctor of Oriental medicine licensed pursuant to this*  
10 *chapter may apply to the Board for an endorsement to practice*  
11 *acupuncture point injection therapy. The applicant must submit*  
12 *with his or her application proof that the applicant has:*

13 *(a) Successfully completed postgraduate coursework approved*  
14 *by the National Certification Commission for Acupuncture and*  
15 *Oriental Medicine or a successor organization which provides at*  
16 *least 24 hours of instruction provided in person, including,*



1 *without limitation, at least 8 hours of instruction received by*  
2 *practicum and 2 hours of training in the administration of*  
3 *intramuscular epinephrine; and*

4 *(b) Obtained or otherwise carries a policy of professional*  
5 *liability insurance which insures the applicant against any liability*  
6 *arising from the provision of acupuncture point injection therapy*  
7 *by the applicant.*

8 *2. The Board shall issue an endorsement to practice*  
9 *acupuncture point injection therapy to an applicant who meets the*  
10 *requirements of subsection 1.*

11 *3. A licensee who is issued an endorsement to practice*  
12 *acupuncture point injection therapy may only inject substances for*  
13 *which the licensee has received training which may include,*  
14 *without limitation, nutritional, homeopathic and herbal*  
15 *substances and local anesthetics, including, without limitation,*  
16 *procaine and lidocaine.*

17 *4. As used in this section, "acupuncture point injection*  
18 *therapy" means the subcutaneous, intramuscular and intradermal*  
19 *injection of substances to stimulate acupuncture points, ashi*  
20 *points and trigger points to relieve pain and prevent illness.*

21 **Sec. 3.** NRS 634A.020 is hereby amended to read as follows:

22 634A.020 As used in this chapter, unless the context otherwise  
23 requires:

24 1. "Acupuncture" means the insertion of needles into the  
25 human body by piercing the skin of the body to control , ~~[and]~~  
26 regulate , ~~[the flow and balance of energy in the body and to]~~ cure,  
27 relieve or palliate ~~[:]~~ *the body for therapeutic purposes:*

28 (a) Any ailment or disease of the mind or body; or

29 (b) Any wound, bodily injury or deformity.

30 2. "Board" means the State Board of Oriental Medicine.

**634A.144 Board prohibited from issuing or renewing license unless applicant attests to certain information related to safe and appropriate injection practices.** The Board shall not issue or renew a license to practice Oriental medicine unless the applicant for issuance or renewal of the license attests to knowledge of and compliance with the guidelines of the Centers for Disease Control and Prevention concerning the prevention of transmission of infectious agents through safe and appropriate injection practices.
