Brett Kandt discussed there are statutory responsibilities from the AG's Office and the AG's Office also is available to assist as needed. Mr. Kandt wanted to remind the Board that the AG's Office is available to render opinions; the Board is to notify the AG's Office when it is served with legal papers; if the Board has to attend a judicial hearing,

the Board needs the AG to be present; and all contracts need to be reviewed by the AG's Office.

18. For Discussion Purposes Only-Discussion regarding the Attorney General's response to the Board's request for a dry needling opinion.

Brett Kandt advised that this item should not be discussed due to attorney-client privilege.

19. Discussion and deliberation regarding 1) issuance and service of cease and desist letters to person(s) engaging in the practice of Oriental medicine without a license by inserting needles into the human body by piercing the skin of the body, whether such practice is called acupuncture, dry needling, or another term of art; 2) issuance and service of citation(s) to person(s) engaging in the practice of Oriental medicine without a license by inserting needles into the human body by piercing the skin of the body, whether such practice is called acupuncture, dry needling, or another term of art; 3) assessment of an administrative fine(s) of not more than \$2,500 as provided in NRS 634A.250 to person(s) engaging in the practice of Oriental medicine without a license by inserting needles into the human body by piercing the skin of the body, whether such practice is called acupuncture, dry needling, or another term of art; or 4) imposition of any combination of the aforementioned penalties (For Possible Action).

Bret Meich stated that these are some options for the Board to consider against person(s) who are practicing dry needling and are not licensed by this Board. Mr. Meich stated that in his legal opinion, it is permissible for the Board to take action.

Motion: Dr. Park motioned to approve for Mr. Meich to issue and serve cease and desist letters to person(s) engage in dry needling

20. For Discussion Purposes Only —Discussion whether to authorize and maintain in any court of competent jurisdiction a suit(s) for an injunction against any person engaging in the practice of Oriental medicine without a license by inserting needles into the human body by piercing the skin of the body, whether such practice is called acupuncture, dry needling, or another term of art.

Dr. Park stated that the Board will start with the cease and desist letter and then take more action as warranted. Bret Meich discussed the judicial injunctive process.

21. Discussion and deliberation to initiate removal of Board approval of Wongu University of Oriental Medicine if its curriculum and required fee(s) are not provided to the Board within 45 days of written notice (For Possible Action)

Paul Larsen disputed Wongu having to pay the \$5000 each year as there is no change to the curriculum. Dr. Park stated the \$5000 annual fee is required by regulation.

22. Discussion and deliberation to direct the Board's executive director to solicit applications for the Board's consideration at its next meeting for the retention of consultants to review and evaluate any curriculum that may be submitted by a school

or university of Oriental medicine for the Board's approval and to make recommendations to the Board on the merits of such curriculum. (For Possible Action)

23. Public Comment (Discussion Only).

Paul Larsen: He is submitting the letter from Wongu as public record. Per the Board in 2012, Wongu is to maintain ACCAOM standards and to advise the Board and ACCAOM of any substantial changes to its curriculum. There has been no changes, and so there is no need for a regulatory review and no need for a fee. Wongu has paid \$5000 in 2016 in good faith. Wongu will pay 2014 and 2015, under protest, in return that this Board make a specific finding that the fees for 2014 and 2015 are not taxes but are fees despite there are no regulatory activity. Wongu will seek judicial review for the Board's actions.

Sharon Roth: She was wondering if there is a form for Wongu to complete each year like other licensees.

Sae Lee: Faith Noborikawa's application should be approved and/reconsidered. Previous similar applicants have been approved by the Board.

Yeaji Suh: Bastyr School has regional accreditation and would not do anything to jeopardize it.

Daniel Davies: Who was designated in 2014 and 2015 to review Wongu's curriculum? What are the criteria for the curriculum reviewers? Are they ACCAOM certified? If so, Wongu is already reviewed by ACCAOM and is meeting ACCAOM standards.
