Dear Ms. Lok,

On behalf of McDonald Carano, I am pleased to offer our proposed project team and proposal to support the Nevada State Board of Oriental Medicine.

We believe we are particularly well-suited to guide you in Nevada because of our extensive network of contacts and excellent working relationships throughout the state, particularly with regard to being active participants in various specialty medicine groups (physicians) throughout the year, including during the Interim, to exchange information and work toward consensus during legislative sessions. We look forward to adding Oriental Medicine's voice to that group.

On behalf of other specialty groups that we represented during the 2017 legislative session, we sincerely appreciated the support of the Board of Oriental Medicine on AB454, the bill to allow traveling physicians and other medical professionals affiliated with athletic teams to treat those team members while in Nevada. As you know, while the bill had universal support, it got hung up in politics, but the language ended up in SB292 and passed.

We also had the pleasure of representing your board during the 2019 legislative session. We worked closely with Senator David Parks to pass SB355. This was, we believe, one of the most hotly contested bills of the 2019 session. The battle lines were drawn early, and the issue garnered extensive media coverage. We prevailed in the end and were able to have our preferred language for "dry needling" and other arts included in statute, across medical disciplines, and we were successful in stipulating sufficient training hours as well.

We anticipate that the opponents of SB355 may attempt to amend the statute in 2021, or simply attempt to expand their scope of practice to include other Oriental Arts. A diligent monitoring of bills with applicable statutes will be paramount. We have already built a comprehensive Bill Draft Request (BDR) monitoring system and are tracking proposed bills that may potentially impact Oriental Medicine.
