PUBLIC HEARING AGENDA LCB No. R026-22

Proposed additions, amendment and/or repeal of regulations, Chapter 634A of the Nevada Administrative Code.

1. Introduction – Open Public Hearing

The purpose of the hearing is to receive comments from all interested parties regarding the adoption of regulations that pertain to LCB File No. R026-22, Chapter 634A of the Nevada Administrative Code.

The proposed regulations relate to Oriental medicine; revising requirements for the proof of qualification of an applicant for licensure to practice Oriental medicine; revising provisions relating to the examinations of an applicant for a license to practice Oriental medicine; revising provisions relating to continuing education requirements; providing that certain courses approved by the National Certification Commission for Acupuncture and Oriental Medicine may be offered as courses for continuing education without approval from the Board; revising provisions relating to the renewal of a license to practice Oriental medicine; authorizing the payment of fees to the Board by credit card or debit card; eliminating the requirement that certain applicants for a license to practice Oriental medicine must pass certain English proficiency tests and demonstrate a reasonable proficiency in the English language during an oral interview at the practical examination; eliminating provisions relating to a licensee operating under a fictitious name; eliminating certain fees; and providing other matters properly relating thereto.
