Dear President Richardson:

At its 4-7 August 2021 meeting, the Accreditation Commission for Acupuncture and Oriental Medicine<sup>1</sup> (ACAOM or Commission) reviewed the Third Institutional and Master's Program Progress Report due 1 June 2021 from Wongu University of Oriental Medicine (WUOM or Institution) documenting the Institution's progress in correcting cited findings of compliance with further development under applicable ACAOM accreditation standards. This report was required by ACAOM's Action Letter dated 24 August 2020.
